Where, notwithstanding the foregoing, I may acquire, by operation of law or otherwise, any right, title or interest to any Content, I hereby unconditionally and irrevocably waive, worldwide, any such right and I shall execute such documents (including any assignments), and take all other steps as are reasonably required in order to give effect to the ownership of Videographer set out above, for no additional fees or royalties.

Without derogating from the above, and by way of illustration, the Videographer's ownership of the Content and license to use the Image as it appears therein includes, but is not limited to, the irrevocable perpetual rights to: modify, edit, transcode, crop, make derivatives of or otherwise change the Content in any manner use, re-use, publish, and re-publish the Content; Merge the Content with other content (visual, oral or other) and/or media; use the Content for illustration, promotion, art, advertising, trade, or any other commercial or non-commercial purpose whatsoever; and allow third parties, including, without limitation, Wix’s users, to do any of the above.
